#### **OLD BUSINESS**

## 1. Reports from Executive Officers:

### A. Welcome remarks - President Ahn

President Ahn noted the team's improved performance at the 2014 World University Taekwondo Championships over past years, with good cooperation among the staff. He also noted that our team and membership includes students from globally top-ranked universities.

## B. 39th NCTA Championships report

Approximately 400 competitors attended the 2014 National Collegiate Taekwondo Championships.

## C. 13<sup>th</sup> WUTC report – Vice President Dan Chuang

Coach Chuang, who also served as one of the coaches of the 2014 US National Collegiate Taekwondo team, noted that the team had one of the best performances in recent years, earning 1 gold and 5 bronze medals, including

Jackie Galloway, who was the first female collegiate world champion from the USA since 2002.

It was noted by Secretary General Vincent Lo that Kent Kitagawa was no longer treasurer and that he was serving as the acting treasurer for the past year.

- b. NCTA team trials waiver for the regional championships winners The idea of giving a waiver to first place finishers at the regional championships into the team trials was discussed and will be added to discussion by the committee.

## 2. MOU development with Kukkiwon about Junior and senior instructor development & certification program


President Ahn discussed an MOU to be signed with the Kukkiwon to bring events to the US like seminars covering exercise physiology, how to address issues like sexual harassment, dojang management, and junior and senior instructor certifications.

## 3. 2015 27th Gwangju Summer Universiade – President

President Ahn is serving as the FISU technical delegate for the Summer Universiade Taekwondo event. He reports that preparations are going well and reminded the assembly that the Universiade Taekwondo event will be a WTF G-2 ranked event and will therefore see a high caliber of competition.

## 4. Selection of 2016 tournament site

The University of Colorado, Boulder proposed to host the 2016 National Collegiate Taekwondo Championships. They noted that they have newly remodeled Recreation Center that would serve as a good venue. The University of Colorado, Boulder was unanimously voted as the site of the 2016 NCTA Championships. Pres. Ahn mentioned that the 2016 National Collegiate Team would have the option of competing at a possible Pan American Taekwondo Championships as well as at a possible FISU/WTF World Taekwondo Festival.
